## MEMORANDUM OF UNDERSTANDING BETWEEN THE CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CORONA-NORCO CHAPTER 369 AND THE CORONA-NORCO UNIFIED SCHOOL DISTRICT

## May 17, 2021 Summer School (Pandemic)

This Memorandum of Understanding (MOU) is between the California School Employees Association and its Corona Norco Chapter 369 (CSEA) and the Corona-Norco Unified School District (District) regarding the expanded Summer Boost Program.

On May 17, 2021, CSEA and the District met and agreed to the following effective May 18, 2021:

- 1. Site administrations shall provide Human Resources a copy of the summer school custodians route/daily schedule before the start of each summer session.
  - 1. The route/daily schedule should include the complete breakdown of the route/daily schedule, including times, the number of classrooms, bathrooms, lunch/snack areas, and handwash stations the custodian is responsible for.
    - 1. The route/daily schedules must include the break and lunchtimes defined by CBA (Article 6.4 and 6.5).
  - 2. No custodian assigned to summer school shall do groundskeeper duties.
- 2. Per Article 6.15, unit members shall work the entire Summer Session they are hired for.
- 3. Incentivization for the 2021 Summer Sessions: Due to the extraordinary need to fill Summer School positions for two (2) summer sessions, the District shall pay classified employees their regular pay plus longevity or Step A of the classification hired into whichever is greater.

This agreement shall be effective until December 31, 2021.

This Tentative Agreement is subject to ratification by CSEA Corona Norco 369 membership, CSEA Policy 610 requirements, and the adoption by the Corona Norco School Board of Education.
