MEMORANDUM OF UNDERSTANDING BETWEEN THE IFORNIA SCHOOL EMPLOYEES ASSOCIA

CALIFORNIA SCHOOL EMPLOYEES ASSOCIATION AND ITS CORONA-NORCO CHAPTER 369 AND THE CORONA-NORCO UNIFIED SCHOOL DISTRICT

March 16, 2022 Summer School

This Memorandum of Understanding (MOU) is between the California School Employees Association and its Corona Norco Chapter 369 (CSEA) and the Corona-Norco Unified School District (District) regarding the expanded Summer Boost Program.

On March 16, 2022, CSEA and the District met and agreed to the following effective March 17, 2022:

- 1. Site administrations shall provide Human Resources a copy of the summer school custodians route/daily schedule before the start of each summer session.
 - 1. The route/daily schedule should include the complete breakdown of the route/daily schedule, including times, the number of classrooms, bathrooms, lunch/snack areas, and handwash stations the custodian is responsible for.
 - 1. The route/daily schedules must include the break and lunchtimes defined by CBA (Article 6.4 and 6.5).
 - 2. No custodian assigned to summer school shall do groundskeeper duties.
- 2. Per Article 6.15, unit members shall work the entire Summer assignment.
- 3. Incentivization for the 2022 Summer Sessions: Due to the extraordinary need to fill Summer School positions, the District shall pay classified employees their regular pay plus longevity or Step A of the classification hired into whichever is greater.
 - 1. Child Nutrition Food Truck Drivers will be offered same duration of assignment, number of hours and pay rate as Paint Crew.

This agreement shall be effective until December 31, 2022.
