Collaboration is a hallmark of the work done in Corona-Norco and is integral to the culture in the district. With that said, we understand that the use of ESSER III funds will directly impact the students, families, and our local community. Therefore, we have engaged with our community to tailor this plan to the specific needs faced by the students and schools. We appreciate the relationships that we have with our students, parents, teachers, classified staff and teachers and value the diversity of opinions that they offer us as a district.

To ensure that we received significant insight into what prevention and mitigation strategies we should pursue in keeping our students and staff safe as well as how the various COVID-19 prevention and mitigation strategies impact teaching, learning and the day-to-day

school experiences, we engaged in meaningful consultation on September 23, 2021, through a community engagement meeting, held via Zoom, that included our diverse stakeholders. The composition of this group was intentional in including families from all grade levels (elementary, intermediate, high school), families that speak languages other than English, parents of students receiving special education services, foster and homeless representation, and school and district administrators, including our Administrative Director of Special Education. Both our local bargaining units were included in providing meaningful input through participation in this meeting, and through a joint communication with our teachers association to allow for participation from all members. CNUSD evaluated its stakeholder engagement opportunities and determined that Civil Rights Groups/Advocates and/or Tribes are neither present nor served by the district.

Student voice is always very important when considering the focus of efforts in CNUSD. Information was gathered from our students regarding their opinions and recommendations about additional support for students in both academic areas and in the area of mental/physical health through a survey that was provided to targeted classes at the 6th grade through high school level.

Additional public input was garnered from our community as a whole through a district survey that was sent to parents via our bi-weekly newsletter. This electronic newsletter, set out by our Communications department, has become a trusted source of district news throughout the pandemic, and one that our community looks to for information and opportunities for engagement. The public was provided a one week window between September 23 and September 30 to share their input. The survey asked for them to rank the importance of various needs within the district such as high quality air/ventilation, intervention supports, class sizes, and student health. Additionally, three open ended text boxes were provided to provide specific input on the supports needed to assist students in the loss of instructional time, the supports needed for parents to assist their children and the health and safety needs that they felt were needed at the school sites.

As part of our ongoing collaboration with our community, Corona-Norco also connected with the following stakeholder groups to discuss how the district should prioritize recovery efforts specifically in the areas of safe in-person learning, lost instructional time, and other pandemic impacts through both our annual LCAP process and Expanded Learning Opportunities Grant: Students; Families, including families that speak languages other than English; School and district administrators, including special education administrators; Teachers, principals, school leaders, other educators, school staff, and local bargaining units. A description of how the development of the plan was influenced by community input.

We are appreciative of the extensive input provided to CNUSD to assist the District in planning for the effective use of one-time ESSER III funds. Within our meetings we shared with our community that these dollars are an opportunity to leverage one-time funding for pandemic recovery and to address gaps in opportunity and outcomes beyond the pandemic. Effective use of these funds

will allow the district to build capacity, strengthen systems for equity, and meet the identified short and long-term needs of students and families. As has always been our practice, we will continue to braid our funding sources to build on existing initiatives, especially those goals and actions identified in the LCAP, and Expand Learning Opportunities Grant.

In reviewing the data gathered from our community over 90% stated that high quality air/ventilation was of moderate to high importance. Approximately 94% shared that intervention supports for students were of moderate to high importance. Lower class sizes were ranked moderately to very important by 95% of respondents. Lastly, 96% shared that student health was of high importance.

Specific recommendations in regards to providing a safe and continuous in-person learning environment included: Upgraded HVAC systems and filtration, purifiers, covered outdoor areas, consistency in facilities, Rapid COVID testing, and increased security. Additionally, requests were made to include extra diligence in cleaning protocols and screening during the upcoming cold/flu season.

In response to this feedback and district needs, CNUSD's ESSER III Plan includes an upgrade to site HVAC systems as well as classroom lonization devices. Lunch tables and umbrellas were purchased to allow for students to social distance during lunch as well as provide outdoor learning spaces. Additional Personal Protective Equipment (PPE) was also provided to ensure that students and staff were safe and able to remain in school.

Input gathered in support of addressing lost instructional time included smaller class sizes, online supplements, before and after school intervention for reading and math, intervention during the day, summer school opportunities and emotional support for both students and families.

The actions in this plan include additional staff to lower class sizes to soft caps where possible and to allow for social distancing. Full time elementary school counselors will be funded for an additional year. Literacy and math supports have been included to strengthen first best instruction. Supplemental curriculum, aligned to the core language arts adoption, will be purchased for Special Education classrooms to provide a scaffold to complex text, enabling students to reach grade-level expectations, through gradual steps. This curriculum will address key literary, informational, and content-area grade-level standards. Additional opportunities for credit recovery will be provided as the loss of instructional time has increased the number of students in need of credits to graduate on time.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - o If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities
 Act, upon request; and
- Be made publicly available on the LEA's website.
